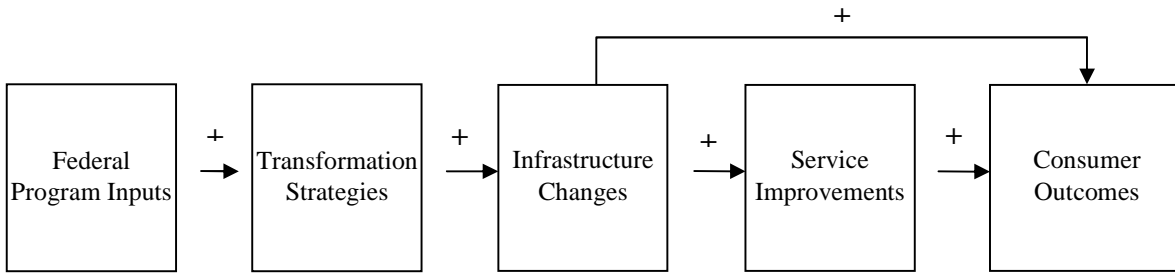


Online Supplement 2: Simplified MHTSIG Program Logic Model. + = positive correlation.
